## **Program Goals**

The Addiction Recovery Mobile Outreach
Team (ARMOT) Program is a collaboration
between the Armstrong-Indiana-Clarion
Drug and Alcohol Commission, Armstrong
County Memorial Hospital, Clarion Hospital
and Indiana Regional Hospital and is
intended to enhance rural physical and
behavioral health care service delivery.

The objectives of the ARMOT program are to:

- Screen patients for substance use disorders at the hospital point of entry
- Refer patients with substance use disorders to ARMOT program for drug and alcohol assessment and supportive services
- Increase the number of patients with substance use disorders that are transferred from the hospital setting directly into drug and alcohol treatment
- Educate hospital staff on substance use disorders
- Reduce ER visits, hospitalizations and inpatient stays for patients
- Assist patients with substance use disorders so that they can bridge the gap between behavioral health and physical health services

### Addiction Recovery Mobile Outreach Team Program

The Armstrong-Indiana-Clarion Drug and Alcohol Commission is pleased to announce the Addiction Recovery Mobile Outreach Team Program for recoverees and county medical professionals.

Two Case Managers and one Certified Recovery Specialist are available to meet with recoverees who become patients of their local emergency department, hospital acute care wing, behavioral health unit or present to their medical practitioner with substance use disorder concerns which aggravate their physical health.

Hospital Liaisons, Case Managers and CRS, are available to Armstrong, Indiana and Clarion County medical professionals to provide Drug & Alcohol Assessments, Case Coordination, and Aftercare assistance. A Certified Recovery Specialist works closely with both Case Managers to provide peer-based Recovery Support Services.

Preferential treatment services are available for pregnant women.

### **Hospital Services**

- Drug & Alcohol Screening and Assessments within the hospital setting
- Referrals to Drug & Alcohol treatment
- Coordination of Care
- Aftercare planning/coordination
- Assistance navigating health insurance benefits for Drug & Alcohol treatment
- Consultation on substance abusing and suspected co-morbid Drug and Alcohol patients
- Recovery Support and Checkups
- Telephone Recovery Support
- Recovery Planning
- Recovery and Addiction Education
- Introduction and engagement to the Recovery Community
- Recovery Support Groups
- Outreach to recoverees in early recovery
- Referrals to Community Resources
- Advocacy

#### Who to refer?

- Patient indicates they use drugs or drink alcohol excessively
- Patients with known history of substance use
- Patients who are detoxing
- Patients with medical conditions related to their substance use
- Patients who are requesting to go to drug and alcohol treatment
- Patients treated after an overdose
- Patients who need help connecting to Drug & Alcohol Services
- Patients experiencing a relapse
- Patients with substance usedisorders and fail a drug screen

Patients must be psychiatrically stable to be considered for admission into Drug and Alcohol Treatment.
